Current Year Dues Report:

Secretary's Report:

ACC Committee Report:

The report was given by ACC Secretary Stroud.

There was a lot of activity recently.

- Homeowner H wants to change her exterior house colors that were previously approved

Property Maintenance:

A motion was made, seconded and approved to send a letter to Homeowner M Homeowner N has 3 horses due to yearling from last spring. A motion was made, seconded and approved to send a letter to Homeowner N about yearling reminding him to move.

Invisible fence - talked to our lawyer who recommends we not have a policy on invisible fences

Officers and Committees:

Talked about current officers and roles. Susy to remain as president, Ginny to remain as Secretary, Bill to remain as Treasurer. Motion was made to retain current officers, there was discussion, amending to add Director Eldenburg as Acting Vice President until a formal decision can be made in June. Motion was seconded and approved.

Motion was seconded and approved.

Overhead fuel tank: Received question from a neighbor whether an overhead fuel tank is allowed. President Ruof spoke with Vice President Martin about whether we have ever allowed them. Director Stroud will ask Weld County code enforcement if there is an issue.

<u>Homeowner B property sightliness.</u> Check for single family housing rules. President Ruof will talk with Homeowner B about sightliness after we answer questions regarding property.

Water Committee Report: Water expense breakdown was provided by Director Coulson.

Water Lease/Rent - Ben Armstead advised that this year Supply gets 2 acre feet per share. We would need \$80 per acre foot to cover our assessment. Harvey Yoakum will rent our water for this amount (total of \$800) 303-588-6071 (for Supply Water). Motion to accept this offer made, seconded, and approved.

Director Coulson will call Mr. Yoakum to accept. Once the check clears the bank, Director Coulson will draft a letter of authorization for Harvey Yoakum and Supply authorizing use of the water shares. President Ruof has such a form on her computer and will look for it. ISH – Director Coulson spoke with Tom Chandler about ISH water. ISH has not issued the number of inches for 2014 yet. Ted Bujalski has bid to rent Northmoor's ISH water shares for \$45 per acre foot. Depending on how many inches are issued, getting \$45 per acre foot will result in \$1980 or \$450 over our assessments. Farmer's Extension and Bunyan Lateral cannot be leased. Director Rieke says Roger Olsen also wants to bid. Discussion ensued on defining a bid process.

Director Rieke would like the acre foot breakdown. Director Coulson to send out this information. ISH water shares will be put out for informal bidding.

<u>Collections Policy discussion.</u> Long discussion. Will modify the policy with payment dates and resend to Board.

<u>Homeowner A trash cans</u> – President Ruof will call Royal Trash to investigate if they can get roller cans.

Annual Assessment payment options discussion. Question posed if we should allowsplit payment of the annual assessment. A motion was made to NOT change the current practice. \$150 due in full and ½ trash of \$60 due 7/1. Motion seconded and approved.
